

La Grange Kentucky Main Street Program PRESENTS Two Markets in 2022:
La Grange Arts Fest (June 4th) and
Trackside Market (Sept 10th)
9:00AM - 5:00 PM

About the Markets:

The street will be closed on the dates of the market for pedestrian traffic only; but the train will “rumble” through town several times during the day. La Grange is the only town in the USA with an active track in the middle of its Main Street. Market Booths will be located on Main Street and adjacent side streets. The LaGrange Farmers’ Market vendors will also be open in their new location on Springs Park (at the end of West Main.)

Vendor Requirements

Both markets are open to vendors selling vintage (25 years old or older) and art/crafts/hand-created items. **NO YARD SALE/NO COMMERCIAL/NO DIRECT SALES BOOTHS PERMITTED. This is a CURATED show, and vendors must meet the show’s criteria.** You will receive notice of acceptance or rejection of your application within 10 business days of receipt of your completed application and payment. Booth fee will be returned if the application is not accepted.

SHOW RULES

Vendors are expected to set up their booths in an attractive manner. Vendors must provide their own tables. Tents are allowed; white tents are preferred but not required. There cannot be any printing on the tent unless it is your business logo. Remember you will probably be on pavement, so bring “anchors” (eg. Blocks, sand bags) for your tents.

State sales tax collection and remittance is the responsibility of the vendor. Neither LaGrange Kentucky Main Street Program nor the City of Lagrange is responsible for any property loss/injury/damage occurring within a vendor’s booth area; and vendors agree to release, forever discharge, indemnify and hold harmless the LaGrange Kentucky Main Street Program and the City of LaGrange from any property loss/injuries/damage occurring within a vendor’s booth area.

ON THE DAY OF THE SHOW- PLEASE DO NOT START PACKING UP YOUR BOOTH UNTIL 4:45 PM.

Booth Information

BOOTH SIZE IS APPROX. 12’ X 10’; BOOTH RENTAL: \$75.00 (one show); \$125.00 (both shows.) You must sign up and pay for both shows with your application to receive the discount. A booth location map will be provided to Vendors by email no later than five (5) days prior to the show date. Set up will be from 6:30 AM to 9:00 AM on Saturday morning. Parking locations for trucks, trailers etc. will be shown on the booth location map. **Unless the event is canceled by the Main Street Program, the booth rental is non-refundable.**
