About our Market

This outdoor market is located in the Historic Main Street area of Lagrange, Kentucky. The train track is truly in the middle of Main Street. The street will be closed on the date of the market for pedestrian traffic only; but the train will “rumble” through town several times during the day. La Grange is the only town in the USA with an active track in the middle of it’s Main Street.

Vendor Requirements

The market is open to vendors selling antique, vintage, re-purposed and/or hand-created items. If you also sell new, commercially produced “vintage-inspired” items or reproduction antique/vintage, these products must be no more than 10% of the product in your booth. **THIS IS NOT A FLEA MARKET OR YARD SALE; NO COMMERCIAL/DIRECT SALES BOOTHS PERMITTED.** You will receive notice of acceptance or rejection of your application within 7 business days of receipt of your completed application and payment. Booth fee will be returned if the application is not accepted.

Vendors are expected to set up their booths in an attractive manner. Staged booths and displays are encouraged. Selling out of storage boxes, plastic bins, the back of your vehicle, etc. is not permitted.

State sales tax collection and remittance is the responsibility of the vendor. Neither LaGrange Kentucky Main Street Program nor the City of Lagrange is responsible for any injury/damage occurring within a vendor’s booth area.

Booth Information

BOOTH SIZE IS APPROX. 12’ X 10’; BOOTH RENTAL IS \$50.00 PER BOOTH. A Booth location map will be provided to Vendors by email no later than September 5th. (East Main Street locations will be assigned first, based on date of receipt of application and payment. Walnut will be assigned next; and other side streets will be used as needed.) Set up will be from 7:00 AM to 9:00* AM on Saturday morning. Parking locations for trucks, trailers etc. will be shown on the booth location map. Event will be held rain or shine- booth rental is non-refundable. Tents are permitted, but booths will be set up on pavement. Tents cannot contain printed advertising, unless it is your shop’s logo. Vendors are expected to keep their booth open until 4:00 PM – please do not pack up early.
